[California Is Primed for a Severe Fire Season, but Just How Bad Is Anybody's Guess](#) - LA Times. "The concurrence of human-caused climate change, which is drying out our forests and grasslands and creating longer stretches of hot weather, and a steady influx of people into remote areas is creating conditions for the perfect fire storm," said Tirtha Banerjee, assistant professor of civil and environmental engineering at UC Irvine.

[COVID-to-Climate Tribal Questionnaire](#). The Pala Band of Mission Indians' Tribal Climate Health Project invites tribal-serving professionals across the US to respond to an [online questionnaire](#) titled "Crisis Response and Recovery in Indian Country: Translating COVID Lessons Into Climate Emergency Preparation." The purpose of this questionnaire is to collect tribal experiences, knowledge, best practices, and lessons learned while responding to and recovering from the COVID-19 pandemic that may be translatable to strengthening tribal preparation for emergencies resulting from climate change. The findings will be used to inform a summary report that will be distributed to Tribes and tribal-serving organizations nationally.

[Emissions Cuts Could Drop the Impact of Melting Ice on Oceans by Half](#) - New York Times. A new study said that limiting warming to 1.5 degrees Celsius could reduce sea level rise from melting ice sheets from about 10 inches to about five by 2100.

[The Simple Local Solution to Sea Level Rise? Mud From the Bottom of San Francisco Bay](#) - SF Chronicle. That's the finding of a

[new report](#) from San Francisco Estuary Institute that tries to address a two-part problem related to the looming threat of sea level rise: the lack of natural sediment coming into the bay and the need to reinforce its shorelines to protect the region from rising seas. The solution? Using sediment that's dredged from the bay's shipping channels to restore wetlands.

[State Water Resources Control Board Prop 68 Grant Funding](#).

Division of Financial Assistance (DFA) is working on a new program to fund the operations and maintenance (O&M) costs for disadvantaged community (DAC) drinking water systems over three to five years. There is up to approximately \$27.5 million in remaining Proposition 68 Groundwater funds that may be used for this purpose. For consistency with Proposition 68 requirements, the program will be focused on systems that are treating contaminated groundwater. If your organization would like to participate in this important effort to support DAC systems, the first step is to submit a Letter of Interest by **July 12, 2021**.
