### In Climate News...

**California Resilience Partnership Celebrates Year One:** It's been a busy year of growth for the [California Resilience Partnership](#) (CRP). When we [launched](#) a year ago, our vision was to generate meaningful partnerships, while bolstering existing efforts, in order to advance resilience projects. [More information here.](#)

The C3JV works to advance conservation efforts within six habitat systems that each have unique assemblages of species, pressures acting on them, and people engaged in their stewardship. Key avian focal species are then used as indicators to help the Joint Venture monitor and assess our conservation impact over time within each habitat system. [LGSEC Impact Report](#) Read board member updates and learn about LGSEC's regulatory engagement in 2021. This report is a great opportunity to celebrate the accomplishments of LGSEC in the last year and summarize the successes and learning opportunities that will drive us forward in 2022!

Released by **California Forward (CA FWD)** in February, the **2022 Roadmap to Shared Prosperity** details the organization's priority actions to help build more inclusive, equitable and sustainable economies that give more Californians the opportunity to thrive. The

Roadmap builds on a year of impressive advancements by CA FWD and its partners including the crafting and passage of the \$600-million Community Economic Resilience Fund (CERF), a \$6-billion investment in broadband and \$1.5 billion to prevent catastrophic wildfires, among others. This month, the California Strategic Growth Council (SGC) published the **California Transportation Assessment (AB 285 Report)** assessing how transportation planning and funding in California support long-term common goals, including building and maintaining a transportation system that advances the state's climate goals and meets the transportation needs of all Californians. The AB 285 report, written by researchers from the University of California Institute of Transportation Studies, analyzes state and regional transportation plans and institutions, funding allocations to various state, regional, and local transportation programs and funding sources, and the legal frameworks that govern how transportation funds are spent in California. In addition, the report identifies initial actions all levels of government and legislators can take to improve quality, sustainability, and equity of transportation in California. **IPCC:** The Working Group II contribution to the Sixth Assessment Report assesses the impacts of climate change, looking at ecosystems, biodiversity, and human communities at global and regional levels. It also reviews vulnerabilities and the capacities and limits of the natural world and human societies to adapt to climate change. [More information here.](#)
