State and Local Updates



Proposition 4 passes: Californians approve \$10 billion for water, wildfire, and climate projects

California voters approved Proposition 4, the state's largest-ever climate resilience bond, with 60 percent support. This \$10 billion investment will fund critical areas such as water infrastructure, wildfire prevention, urban green spaces, and sustainable agriculture. The funding intends to improve water security, protect ecosystems, support community adaptation, and ensure long-term environmental sustainability by taking a comprehensive and interconnected approach to climate challenges. What does this mean for the Central Coast?

Prop 4 provides \$1.2 billion for coastal and ocean resilience projects, including the protection and restoration of critical ecosystems like coastal wetlands, dunes, and kelp forests. These efforts can help mitigate the effects of sea level rise, improve flood resilience, and protect biodiversity, all of which are critical to the Central Coast's natural resources and local economies. California to Receive Nearly \$1.2 Million from EPA to Help

Businesses Prevent Pollution


California is set to receive nearly \$1.2 million in funding from the United States Environmental Protection Agency (EPA) to assist businesses in implementing pollution prevention strategies and decreasing hazardous waste. These funds are part of the EPA's Pollution Prevention (P2) grant program, which promotes environmentally and economically sustainable practices.

The initiative aims to help businesses become more efficient, reduce waste, and improve the use of resources. By directing efforts towards preventing pollution at source, the program reduces the need for costly cleanup efforts and mitigates environmental impacts before they happen. Read more here!

Measure Q: Santa Cruz County's New Water and Wildfire Parcel Tax

This November, Santa Cruz County voters approved Measure Q, establishing an \$87 annual parcel tax to fund projects aimed at protecting water quality, reducing wildfire risks, and preserving natural habitats. The tax is expected to generate \$7.3 million annually. Funds will support local initiatives through grants, city and community-managed projects, and efforts by organizations like the Resource Conservation District. Coastal California Environmental Justice Mapping Tool



The Coastal California Environmental Justice Mapping Tool (CCEJ Tool) is a step towards identifying whether a project, policy, or program will affect environmental justice communities disproportionately along the coast. The CCEJ Tool was developed to assist applicants, analysts, and the public with the implementation of the California Coastal Commission's Environmental Justice Policy. The CCEJ Tool consolidates a variety of public data to assist staff, applicants and the interested public in considering potential environmental justice implications of projects in the California Coastal Zone. The CCEJ Tool includes jurisdictional, environmental, and demographic data and indexes produced by various organizations. Looking at overlays or combinations of these data layers may assist users in considering whether projects may have unequitable environmental impacts.

Funding & Grant Opportunities

The CSCI is now accepting grants to help communities accelerate climate resilience plans and projects

The Climate Smart Communities Initiative (CSCI) is now accepting grant applications to help communities accelerate their climate resilience plans and projects. To be eligible for consideration, a community must be located in the United States and facing significant climate-related challenges, based on environmental as well as socioeconomic considerations. For the purposes of the grant program, a community must be represented by a community-based organization and a local, regional or tribal government entity working collaboratively, and they must complete the application in partnership with an adaptation professional. The initiative will accept applications into March of 2025, and expects to announce the awards in the summer of 2025. Read more on prior grant recipients.

3C-REN Energy Efficiency Programs

3C-REN is pleased to announce the launch of two new programs to enhance energy efficiency in our community: Commercial Energy Savings and Agriculture Energy Solutions. Both programs are part of our ongoing commitment to reduce energy use and support the Central Coast's transition to a more sustainable energy future.

<u>Commercial Energy Savings</u> offers incentives to lower the cost of energy improvements at small and medium-sized businesses. Example projects might include water heater replacements, HVAC or refrigeration upgrades, and building insulation. The program not only aims to lower utility bills for business owners but also promotes sustainable decarbonization practices—contributing to a healthier environment for everyone.

Agriculture Energy Solutions is designed specifically for tri-county farmers and agricultural producers with high energy usage, such as controlled environment agriculture and greenhouse operations. Recognizing the unique challenges this sector faces, the program offers specialized assessments to properly scope energy

efficiency projects and connects producers to eligible incentives to help pay for upgrades. By investing in modern practices, farmers can potentially improve productivity while minimizing energy costs.



Annual Funding Opportunity from the National Fish Habitat Partnership

The California Fish Passage Forum receives funding through the National Fish Habitat Partnership via the U.S. Fish and Wildlife Service to advance shared goals of protecting, restoring, and enhancing fish habitat, with the Forum's specific focus on anadromous fish populations in California. To fund a diverse portfolio of projects, strong project proposals that request less than \$100,000 are preferred. However, the Forums may fund proposals of particular merit at a higher level, at their discretion. Applications are now open for the latest round of Partners for Places grants

Partners for Places aims to enhance local capacity to build equitable and sustainable communities in the United States and Canada. These matching awards support the planning and implementing of urban sustainability and green stormwater infrastructure projects. The deadline to submit proposals is February 28, 2025. CAL FIRE Forest Health Grants

CAL FIRE provides funding for active restoration and reforestation activities to promote resilient forests. These grant funds help ensure the future of California's forests while also mitigating climate change, protecting communities from fire risk, strengthening rural economies, and improving California's water and air The proposals are due by January 15, 2025. Apply here!

Coastal Conservancy Grants

The State Coastal Conservancy (SCC) accepts grant applications on an ongoing basis for projects that benefit public access, natural resources, working lands, and climate resilience on the California coast and in the entirety of the nine SF Bay Area counties. The priority is to advance nature-based solutions where possible, with a focus on on-the-ground project development, including getting from concepts to implementable projects. Funded activities may include: (1) property acquisition; (2) project planning, including community capacity-building and involvement, feasibility, design, environmental review, permitting; and (3) construction and project-related monitoring. The funding does not have a maximum or minimum grant amount, but SCC anticipates that most grants will fall within the range of \$200,000 to \$5,000,000. Learn more here!

Transformational Habitat Restoration

NOAA Fisheries has announced its final round of funding for the Transformational Habitat Restoration and Coastal Resilience Grant. This opportunity supports projects that restore marine, estuarine, coastal, or Great Lakes ecosystems while enhancing resilience to climate hazards. The grant is open to non-profits, for-profit organizations, Native American tribal organizations, and state or local governments. With no match requirement, the program will provide up to \$100 million in total funding, with a maximum of \$10 million per project. Funded projects will span a three-year timeframe.
