Climate Resilient Monterey Bay Grant Gains Momentum with Regional Action Network Launch

Now seven months into the 5-year Climate Resilient Monterey Bay grant, CMSF has officially launched the Monterey Bay Climate Adaptation Action Network (MBCAAN), bringing together 22 organizations to support coordinated regional climate action. Despite federal transition challenges, the initiative is strengthening partnerships and building long-term capacity for inclusive, community- and Tribal-led adaptation efforts across the region. Santa Barbara County Moves to Phase Out Oil Drilling

On May 13, the Santa Barbara County Board of Supervisors voted to begin developing an ordinance to phase out oil drilling, marking a major step toward protecting community health and the climate. Backed by broad public support and over 50 organizations, the move aligns with the county's Climate Action Plan and its goal to cut greenhouse gas emissions 50% by 2030. County staff will return in October with a proposed timeline, budget, and next steps for the ordinance process. Learn more.

New Central Coast AgLink Connects Land Stewards to Regenerative Agriculture Incentives

The Community Environmental Council has launched the <u>Central Coast AgLink</u>, a new platform designed to connect land managers and agricultural producers with funding and resources to support regenerative agriculture practices. The tool helps streamline access to incentives and technical assistance, accelerating the region's transition to more climate-resilient farming.

CMSF Leads Efforts on Environmental Monitoring Guidance for Offshore Wind Development

Scientists from CMSF and Cal Poly Offshore Wind team, alongside CA DFW and the OPC, are collaborating to complete the Environmental Monitoring Guidance Interim Memo by July 2025 to provide key recommendations for baseline data collection and cost-effective monitoring strategies to support responsible offshore wind development. CMSF is also helping the Monterey Bay Aquarium organize a West Coast summit on floating offshore wind impacts planned for October 2025. Learn more.



Santa Cruz's West Cliff Vision Wins Resilience and Sustainability Award

Congratulations to the City of Santa Cruz and Farallon Strategies for receiving the 2025 Resilience




and Sustainability Award for "A Resilient West Cliff, Accessible to All." This community-driven vision emerged after 2023 storm damage and sets a bold path for coastal resilience, equitable access, and sustainable shoreline management. With over 1,500 community touchpoints, the plan prioritizes nature-based solutions, pedestrian and bike access, and long-term adaptation through a newly adopted five-year Roadmap.

RCPWG Leads Monterey Bay Adaptation Roadmap into Next Phase

The Regional Climate Policy Working Group (RCPWG) is advancing the Monterey Bay Adaptation Roadmap with strong community engagement. Following a successful first workshop focused on local climate concerns, the group is now moving into the project prioritization phase, guided by a detailed spreadsheet of adaptation measures and community feedback. State Opportunities

Building Initiative for Low-Emissions Development Program (BUILD)

CA Energy Commission

\$200,000,000 available to provide incentives and technical assistance to adopt advanced building design and all-electric technologies in new, low-income all-electric homes and multifamily buildings.

Eligibility: Private and public owners or developers, nonprofits, Tribal communities

Deadline: Rolling

County-wide and Regional Funding Program State Water Resources Control Board

Various grants to fund drinking water projects that address drought-related and contamination issues, especially for state small water systems and domestic wells serving

disadvantaged communities and low-income households. Total funding amount per project is dependent on eligibility and availability of funding at time of application.

Eligibility: Nonprofits, Public Agencies, and Tribal Governments

Deadline: Rolling

Watershed Restoration Grants CA Department of Fish and Wildlife

\$200,000,000 available to fund restoration projects that address drought, urgent degrading water and habitat conditions due to climate change impacts, Wetlands and Mountain Meadows Restoration, wildlife corridors, Proposition 1, or Proposition 68.

Eligibility: Nonprofits, Public Agencies, and Tribal Governments

Deadline: Rolling

<u>Disaster Relief, Recovery, and Resilience Fund</u> League of California Community Foundations

Various grants to support the relief, recovery, and resilience for natural hazard events in communities through a statewide coalition of community foundations.

Eligibility: Community Foundations

Deadline: Rolling

Senate Bill 1 Sea Level Rise Adaptation Planning Grant Program

The Senate Bill 1 (SB 1) Sea Level Rise Adaptation Planning Grant Program provides funding to local and regional governments in California to develop sea level rise (SLR) adaptation plans and implementation projects that enhance coastal resilience. With \$19.97 million currently available, the program supports projects in two tracks: preplanning and planning (Track 1) and implementation (Track 2, anticipated in mid-2025). Technical assistance is available to disadvantaged communities, small or rural areas, tribes, and other eligible applicants.

Deadline: The next deadline for full Track 1 proposals is July 3, 2025

California Coastal Conservancy Grants

The State Coastal Conservancy (SCC) offers ongoing grants for projects that enhance public access, natural resources, working lands, and climate resilience across California's coast and the nine SF Bay Area counties. Priority is given to nature-based solutions and advancing projects from concept to implementation. Grants typically range from \$200,000 to \$5,000,000.

Eligibility: Eligible activities include property acquisition, project planning (feasibility, design, community involvement), and construction/monitoring.

Deadline: Ongoing



BEACON Awards Are Open

Apply for a Beacon Award Today and showcase your agency's leadership in climate action and sustainability. From reducing greenhouse gas emissions to advancing climate resilience and innovation, local agencies are invited to apply for recognition across multiple award categories. Applications are due Tuesday, July 15, 2025.

Regional Opportunities

3C-REN Commercial Energy Savings Program

3C-REN Commercial Energy Savings Program is a locally driven program that provides incentives and resources to businesses in San Luis Obispo, Santa Barbara, and Ventura counties to help businesses achieve their energy goals. The program offers incentives for energy efficiency upgrades, flexible solutions for small to medium-sized businesses, support for businesses seeking to lower greenhouse gas emissions, among other services.

Get Help Going Electric: Free DCAP Application Assistance Sessions This Summer

The Driving Clean Assistance Program (DCAP) offers income-eligible Californians up to \$12,000 in incentives to replace older vehicles with electric ones, plus support for EV charging and leasing. Through August, CEC is hosting free in-person and virtual sessions to help applicants complete the DCAP application and access these savings. California E-Bike Incentive Project Application Launching May 29th

The California E-Bike Incentive Project provides up to \$2,000 of point-of-sale incentives to support the purchase of a new electric bicycle (e-bike).

Heat Clean Program Launching May 8th

The Santa Barbara County Air Pollution Control District launched the Heat Clean Program on May 8. This voluntary program provides vouchers of up to \$12,000 to help households replace a wood-burning fireplace or stove with an electric heater such as a heat pump or electric fireplace insert.
