### In Climate News...

GreenLatinos has launched the [Latino Climate Justice Framework \(#LCJF\)](#), a groundbreaking new report highlighting the issues disproportionately affecting our Latino/a/x community and providing a blueprint for an equitable future. This historic movement is the culmination of a year-long process to co-create with nearly two dozen Latinx organizations a lasting framework for addressing the climate crisis that prioritizes environmental justice and elevates Latino/a/x priorities. The LCJF integrates the unique perspectives of members across the country on where and how climate action must address the disproportionate issues nuestras comunidades face.

California Natural Resources Agency (CNRA) and the USDA Forest Service, along with support from Google.org, Google's philanthropic arm, has developed [Planscape](#) – a new wildfire resilience planning tool that uses state and federal resilience data to create user-friendly models that will be easily accessible to land planners. A demonstration of Planscape was released today at the California Wildfire & Forest Resilience Task Force meeting.

Researchers at the The Ocean and Coastal Policy Center at UCSB (OCPC) has launched their map-based [California Coastal](#)

[Adaptation Planning Inventory](#). Funded by the [California Ocean Protection Council](#), the inventory is supporting an OCPC assessment of adaptation planning in communities on the outer coast. The inventory is being developed to support those working toward the California goal that coastal communities be well prepared for sea level rise through actionable coastal adaptation.

## Funding Opportunities

[The Parks Pass Program](#), a partnership between California State Parks and the California State Library as part of the [Outdoor Access for All Initiative](#), supports all Californians in exploring the outdoors and gaining the benefits of our parks through the creation of the California State Library Parks Pass and a grant program. The goals of the program are to generate positive impacts in the areas of health, natural resource stewardship, and historical and cultural connections with an equity lens.

[California Coastal Commission Whale Tail Grants](#). WHALE TAIL® grants support experiential education and stewardship of the California coast and its watersheds. Education and stewardship projects relating to climate change as it impacts the coast and ocean are eligible and encouraged. Shoreline cleanup and coastal habitat restoration projects that have an educational component are also eligible for these grants. Application deadline is **November 4th**.

[EJ4Climate Grant Program](#). The Commission for Environmental Cooperation (CEC) of North America has just announced that the US\$2 million Environmental Justice for Climate (EJ4Climate) grant program is now open for applications. This cycle of EJ4Climate grants will focus on projects in Canada, Mexico, and the United States that integrate community-led environmental education in support of environmental justice and community resilience to climate-related impacts, with up to C\$200,000 in grant funding available for recipients. Proposal deadline is **November 11th**.

On **October 24th**, [Mosaic](#) will open a \$5.5 million RFP to support local to national movement infrastructure that enhances diverse and collaborative implementation of four key statutes and initiatives – the Inflation Reduction Act, Bipartisan Infrastructure Law, Justice40, and 30x30.
