NOAA released the draft designation documents for the [Chumash Heritage National Marine Sanctuary](#) – the first Tribally nominated National Marine Sanctuary. Public comments due October 25, 2023.

New website for [Uplift Central Coast](#). This group encompassing six counties is in a unique position to create an economic development plan specific to the needs of the region it serves. Uplift Central Coast will work to determine how best to use CERF funds for maximum impact for residents, creating a comprehensive plan for how to allocate resources.

The River Network created a two-part toolkit on [Fostering Community Leadership](#) and [Fostering Community-led Research and Knowledge](#) that aims to build the capacity of organizations to serve as catalysts in supporting members of their communities stepping into leadership roles, as well as engaging them meaningfully in defining the scope of local climate change risks and impacts, and formulating and implementing equitable solutions alongside key partners.

Funding and Job Opportunities

Indigenous Ways of Knowing in Decision-Making RFP – The Lenfest Ocean Program seeks to fund projects that elevate Indigenous Peoples in sharing their traditions, culture, knowledge, and wisdom to improve evidence-based decision-making for the management, conservation, and restoration of coastal marine species, habitats, and ecosystems. Marine Debris Challenge Competition – Sea Grant anticipates approximately \$16,000,000 will be available to support innovative, transformational research to application (R2A) projects that will address the prevention and/or removal of marine debris, with award periods of three years. This competition will support innovative research to application (R2A) projects that will address the prevention and/or removal of marine debris and provide the potential for transformational behavior change. Equity and Access Grant Program – Three grant accounts will provide funding to California Tribes and CBOs to participate in CA Public Utilities Commission processes and make clean energy programs more accessible to underserved and underrepresented communities, including communities that are geographically and racially diverse and socio-economically disadvantaged. Varying due dates; **Equity, Engagement, and Education (EEE) Grant Account is due October 31, 2023.**

2023 WHALE TAIL® Grants – WHALE TAIL® Grants support experiential education and stewardship of the California coast and its watersheds. Grant projects can engage youth or adults and can take place anywhere in California. Education and stewardship projects relating to climate change as it impacts the coast and ocean are eligible and encouraged. Shoreline cleanup and coastal habitat restoration projects that have an educational component are also eligible for these grants. Webinar will be on September 20th. NASA Catalyst Funding – Draft solicitations are out now for this new program to develop an Earth observing system to catalyze biodiversity conservation at large scales, starting in California.

NOAA 2024 Effects of SLR Grant Funding – This grant program aims to help sea level rise adaptation and planning efforts through research, modeling, and testing mitigation strategies. Letters of Intent due **November 13, 2023**. Full proposals due **January 24, 2024**.

Transformational Habitat Restoration and Coastal Resilience Grants – Projects selected through this funding opportunity will have a transformative impact for coastal communities and tribes across the country. They will help sustain our nation's fisheries, make significant strides in the recovery of threatened and endangered species, and

help protect coastal communities and ecosystems from the impacts of climate change. They will support efforts such as reconnecting rivers to their historic floodplains, outplanting corals to rebuild reefs, building living shorelines that protect coasts from erosion and sea level rise, and more. [Climate Ready Workforce](#) – Sea Grant and the NOAA Climate Program Office, with support from the NOAA Office for Coastal Management, seek to establish programs aimed at placing people across the country into good jobs that advance climate resilience and assisting employers in developing a 21st century workforce that is climate literate, informed by climate resilience, and skilled at addressing consequent challenges. NOAA will assist communities in coastal and Great Lakes states, territories and tribes so they may form partnerships that train workers and place them into jobs that enhance climate resilience. **[Letters of Intent](#) due November 30, 2023**.

[Coastal Habitat Restoration and Resilience Grants for Tribes and Underserved Communities, Under the BIL and IRA](#) – Support opportunities for Tribes, and/or Tribal entities, and underserved communities to meaningfully engage in coastal habitat restoration activities. Funding will prioritize capacity building, science support, and restoration project activities that enhance resilience of Tribes, Tribal entities, and underserved communities and have the greatest potential to lead to habitat restoration in coastal, estuarine, marine, and Great Lakes areas. **[Apply](#) by December 19, 2023**.
