News and Updates



The Guadalupe-Lompoc Initiative Launched in October

The <u>Guadalupe-Lompoc Initiative</u> kicked off their efforts in Guadalupe and Lompoc this month with a kick-off event and a check presentation with Senator Monique Limón. The Guadalupe-Lompoc Initiative is a multi-year collaborative effort

supporting community-based organizations and local governments across Santa Barbara County and the Central Coast. Through a \$1.625 million grant, the initiative will focus on capacity building, planning, project development, and community engagement to address air quality, extreme heat, water supply, food security, and wildfire risk. NOAA Launched their Climate Resilience Regional Challenge Grant Program in Moss Landing

Regional leaders and environmental organizations gathered at Moss Landing Marine Labs on October 11, 2024 to celebrate a \$71.1 million federal grant awarded to the Central Coast. The grant supports regional adaptation projects for climate resilience of Monterey Bay coastal communities, including projects that address sea level rise, wildfire, and drought. The funding will support fire risk reduction across 7,000 acres, coastal habitat restoration to mitigate flooding in vulnerable areas, and the creation of a revolving fund for climate adaptation. During the event, local, state, and national leaders emphasized the importance of collaboration with the U.S. Rep. Jimmy Panetta highlighting Monterey Bay's research institutions as key partners in reducing climate risks. NOAA's Rebecca Smyth praised the proactive approach, noting how communities are organizing to prepare for future climate challenges. See below for coverage of the event:

Next Ocean Protection Council (OPC) deadline for SB1 Grant Program is December 20th, 2024

Track One proposals (projects in the Pre-planning, Data Collection, and Planning Phases) are now being accepted through a rolling, quarterly process. See the SB 1 Grant Program Solicitation (PDF) for details on this funding opportunity. Applicants must use the SB 1 Track 1 Proposal Template and Instructions (.docx), and be sure to address the minimum criteria listed in the SLR Adaptation Criteria. While the SB 1 Grant Program operates on a rolling, quarterly basis, and proposals can be submitted at any time, all projects must be brought to Council meetings for funding approval and award. The following interim deadlines are in place to ensure projects can be reviewed and considered for funding in time to be brought to OPC's quarterly Council Meetings.

What the California Legislature Achieved on Climate in 2024

October 31 | 10 am - 11:30 am PST

Climate progress in the California legislature in 2024 was nowhere near what is needed to address the accelerating climate crisis. While our leaders must do more to rein in climate pollution and challenge Big Oil's political influence, there are signs of hope to build on. This year, climate champions introduced bills to defend and grow California's clean energy economy as well as make polluters pay for the costs of addressing the climate crisis. SB 59 (Skinner) aims to transform California's more than 1 million electric vehicles into a source of affordable, reliable, resilient, and clean backup power. SB 1374 (Becker) seeks to support schools' and apartment dwellers' use of solar power. And AB 1866 (Hart) was designed to require oil companies to accelerate the plugging and clean-up of their idle wells. In this webinar, we will discuss the key climate and energy legislation that passed, bills that were watered down or failed, and strategies to increase climate ambition in California. Register here!
