[State Coastal Conservancy](#) recently released their [Draft Strategic Plan 2023-2027](#) for public comment! Public comments can be made through **October 1, 2022** on [this form here](#).

The [Regional Needs Assessment report](#) presents the findings from 13 individual needs assessment processes that were conducted between 2017 and 2021 by the Disadvantaged Community Outreach Partners, from a Tribal needs assessment process administered by five Tribal Outreach Partners, and from the peer-to-peer needs assessment to understand how people experiencing homelessness are accessing water for drinking, sanitation, and hygiene.
