### **News and Updates**

NOAA just released the draft designation documents for the <u>Chumash Heritage National Marine Sanctuary</u> — the first Tribally nominated National Marine Sanctuary. NOAA is hosting <u>in person and virtual workshops</u> on the Sanctuary and public comments starting in September. Public comments <u>due October 25</u>, 2023.

Biodiversity Day, taking place on Thursday, September 7, 2023, marks the anniversary of the launch of the <u>California Biodiversity Initiative in 2018</u>. It's a great time to pause and appreciate our state's unique natural resources, as well as reflect on where we've been, where we are, and where we want to go as a state. Community Based Engagement Services RFP — The Uplift Coalition is pleased to announce we are seeking proposals from qualified Community-Based Organizations experienced in outreach and engagement to diverse and underserved communities in one or more of the six counties that make up the Central Coast CERF region.

Apply here by September 11, 2023 at 5 pm.

<u>Tribal Nature-Based Solutions Grant Program</u> – accepting applications for this new grant program to support California Native American tribes in reacquiring ancestral land, addressing impacts of climate change on their communities, and conserving and protecting biodiversity. The deadline for submitting standard preliminary project proposals is **September 29, 2023**.

**2023 WHALE TAIL® Grants** – WHALE TAIL® Grants support experiential education and stewardship of the California coast and its watersheds. Grant projects can engage youth or adults and can take place anywhere in California. Education and stewardship projects relating to climate change as it impacts the coast and ocean are

eligible and encouraged. Shoreline cleanup and coastal habitat restoration projects that have an educational component are also eligible for these grants. Webinar will be on September 20th. Register <a href="here">here</a>. Apps due November 6, 2023.

NASA Catalyst Funding – Draft solicitations are out now for this new program to develop an Earth observing system to catalyze biodiversity conservation at large scales, starting in California.

<u>Transformational Habitat Restoration and Coastal Resilience</u>
<u>Grants</u> – Projects selected through this funding opportunity will have a transformative impact for coastal communities and tribes across the country. They will help sustain our nation's fisheries, make significant strides in the recovery of threatened and endangered species, and help protect coastal communities and ecosystems from the impacts of climate change. They will support efforts such as reconnecting rivers to their historic floodplains, outplanting corals to rebuild reefs, building living shorelines that protect coasts from erosion and sea level rise, and more. **Apply** by **November 17, 2023**.

Climate Ready Workforce — Sea Grant and the NOAA Climate Program Office, with support from the NOAA Office for Coastal Management, seek to establish programs aimed at at placing people across the country into good jobs that advance climate resilience and assisting employers in developing a 21st century workforce that is climate literate, informed by climate resilience, and skilled at addressing consequent challenges. NOAA will assist communities in coastal and Great Lakes states, territories and tribes so they may form partnerships that train workers and place them into jobs that enhance climate resilience. Letters of Intent due November 30, 2023.

Coastal Habitat Restoration and Resilience Grants for Tribes and Underserved Communities, Under the BIL and IRA — Support opportunities for Tribes, and/or Tribal entities, and underserved communities to meaningfully engage in coastal habitat restoration activities. Funding will prioritize capacity building, science support, and restoration project activities that enhance resilience of Tribes, Tribal entities, and underserved communities and have the greatest potential to lead to habitat restoration in coastal, estuarine, marine, and Great Lakes areas. Apply by December 19, 2023.
